Bandito is mixed with peanuts, pretzels, sesame sticks, and corn sticks with a blast of spicy flavor.

GENERAL SPECIFICATION:

The product must have the aroma and flavor characteristics of peanuts, Pretzels, sesame sticks, corn sticks with garlic, chili pepper and other spices. All deliveries shall conform in every respect to the provisions of the Federal Food, Drug & Cosmetic Act and regulations promulgated thereunder. The product shall be prepared, processed and packaged meeting the requirements of 21 CFR, Part 110, "Current Good Manufacturing Practice." There will be a HACCP program in place to eliminate physical, chemical and microbiological hazards.
